Regulatory Standards and Trends

- According to The Joint Commission:
 - Standard IC.02.02.01 states "The hospital reduces the risk of infections associated with medical equipment, devices and supplies."
 - With a lack of monitoring and documentation of sterilization or high-level disinfection of equipment it is difficult to track the use of equipment on a specific patient, complicating the patient notification process when an outbreak occurs.

• UDI: An FDA Initiative

#CtUC2018

 The UDI initiative evolved out of the fact that there was no system that could collect on-going data on medical devices and link individual patients to a specific device to which they have had exposure. But change is coming...

Important Note...

- If your sites scans instruments to containers/sets in Assembly/Prep and Pack, CensiTrac keeps track of what instruments were part of which containers/sets for a specific case on a certain date.
- OR only scans containers/sets to case tracking





Barriers to Patient-level Tracking

- Industry moved toward rigid containers ("Cans")
- Each set labeled on the outside of the container and inside basket using a dynamo label maker
- RNs were to document the number of sets used in patient's electronic health record
- No way of tracking location or usage of set
- Multiple hiding places for sets
- When a set was missing, process that supported tracking containers fell apart



Using CensiTrac to Your Advantage

- Key functionality to link sets to cases
 - Options to minimize scans based on processes
 - OR Scheduler to promote efficient delivery to the OR
- Process options to support tracking assets to cases
 - Good
 - Better
 - Best
- Reporting tools to retrieve data when needed



Determining Scan Points (Good Options)

- SPD links sets to Case (Good Option)
 - track assets built to a case cart using manual case tracking
- SPD links sets to Case (Better Option)
 - track assets built to a case cart using the OR scheduler interface
- OR links sets to Case (Best Option)
 - OR staff scans only the used assets after each case
